NB: The bidding duration will be 30 Minutes. In case, any valid bid received in last 3 minutes of the auction duration, auction will get extended for 5 minutes. There will be a maximum of 3 extensions of 5 minutes each will be allowed.

Terms & Condition for Sale of Mahua Flower procured under the MSP scheme 2022 crop

1. ITEMS, QUALITY AND QUANTITY

- I. The stocks of Mahua Flower (hereafter referred as "Goods" also) are offered on "**As is Where is Basis**" at the details of the Godown / Cold Storage are as mentioned in **Annexure-1**.
 - II. Interested parties (Registered Buyers/Manufacturers/Exporters etc) may visit the respective locations/godowns/cold storages for inspection of the Goods prior to the bidding process, with intimation to concerned person at Jila Laghu Vanopaj Union, North Balaghat.
 - III. Bidders can bid for any quantity as specified in Annexure-1 in respect of the godown/cold storage.
- 2. Upon confirmation of sale (Bid Confirmation) by JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT, Acceptance Order will be sent to all successful bidders and e- Auction Service Providers through email.**

3. PRICE

Price is to be quoted on “As is where is” basis. The evaluation and finalization of bids received shall be made based on the highest price quoted by the bidders. Price quotation will be in **Rupees/Quintal**. The price quotation would be on “Gross Weight Basis”. 5% GST, 1% ABS, Mandi Tax & 2.5% Income tax will be applicable over and above the price quoted. Other taxes if any, will be charged extra from the buyer as applicable.

4. VALIDITY

The Bids of all Bidders at the final close of the e-auction session must remain valid for a period of 7 (seven) JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT working days after completion of the auction session.

5. PRE-REQUISITES FOR BIDDING

Bidder(s) referred to in this notice is any real individual or legal entity who wishes to buy Mahua Flower items. Only the members registered with the above Service Provider (BSE E- Agricultural Markets Ltd, BEAM) can become bidders in the auction process on the electronic platform. Registration can be done after fulfilling all the terms & conditions put in place for the e-Auctions.

Buyers may participate in the e-auction after registration with concerned Service Provider (BSE E-Agricultural Markets Ltd, BEAM), however payment of disposed quantity should be received from the account of successful bidders and delivery/sale order shall be issued in the name of the successful bidders. Bidders may contact the Concerned Managers/Incharge, JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT for any clarification regarding location of the warehouses/cold storages. Details given at Annexure-I.

6. SAMPLING AND INSPECTION OF GOODS

The stocks are stored in Cold Storages / Godown in the State as mentioned in Annexure – I. In case the buyers/ bidders are keen to verify the quality before participating in bid, they may contact the In-charge Concern of Jila Laghu Vanopaj Union, North Balaghat as per the details given at Annexure-I.

7. EMD DEPOSIT

“Bidders will have to deposit an amount equal to 10 % of Total Bid Value as EMD (Earnest Money Deposit) in the Bank account provided by BSE E-Agricultural Markets Ltd (BEAM) prior to the scheduled date of e-auction. Only those bidders will participate in the e-auction who deposits 10% EMD amount at BEAM’s bank account prior to scheduled date of e-auction. BEAM will share the details of the EMD amount deposited by the prospective bidders through email, before start of the e-Auction to JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT. Once the auction initiated, no request for EMD deposit / confirmation will be entertained by BEAM. BEAM will have to give the details of the EMD deposited by the bidders through email before start of e-Auction.

8. DEPOSIT OF SALE VALUE

The Acceptance Order to the H1 bidder will be issued within 15 working days from the date of the approvals from JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT. The Successful bidder(s) shall deposit

100% sale value within 7 bank working days from the issue of the Acceptance Order/Confirmation Order of JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT. In case, non-receipt of 100% Sale Value within stipulated time of 7 working days, the allotment shall be cancelled, and 10% Earnest Money Deposit would be forfeited after the deduction of BEAM transaction charges (with applicable GST extra). No extension shall be granted beyond maximum period of 7 days. In such case, the forfeited amount shall be remitted to JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT.

9. ONLINE BIDDING/e-AUCTION SESSION DETAILS

- I. The Mahua Flower Stock auction shall be conducted as English Forward on the e-auction portal of BSE E-Agricultural Markets Ltd (BEAM).
- II. Bidders shall have to quote Bid Price in Rupees Per Quintal on the e-auction portal of BEAM to purchase before completion of e-auction time, through their respective User ID & Password provided to them by BEAM after their registration at BEAM's portal.
- III. Bidders can bid for any quantity put on auction stored at a particular warehouse/cold storage i.e., auction will be English Forward.
- IV. The auction session will be open for 30 minutes duration and there will be 03 extensions of 5 minutes each. Each Extension will come into effect, if any bid is received in the last 03 minutes of closing of the initial auction session or the extension session. The detail schedule of e-Auction is at Annexure – III.
- V. The bidders shall place their bids on the auction platform of BEAM (<https://bsebeam.com/>), online system made available by them as per the terms and conditions mentioned below.
 - a) The precedence for allotment will be accorded to the buyer who has quoted the Highest price.
 - b) In case, two or more buyers bid the same price, precedence will be given to the buyer who has offered his bid first with reference to time and the volume.
 - c) In case multiple service provider, the highest bid(s) received among all Service Providers, shall be treated as the H- 1 bid discovered for the e-Auction.
 - d) All the bids so made shall be depicted as 'Provisionally Allotted'. The 'Provisionally Allotted' stock is indicative only and is subject to acceptance of the H1 Bid/Price by JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT.
 - e) The highest bids accepted by JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT will be communicated to the concerned Bidder and respective Service Provider in shape of Acceptance Order.
 - f) JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT may or may not accept the H-1 bid. It will be solely at the discretion of the JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT.
- VI. Allocation Rules: After the approval of the H1 price by JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT, Acceptance Orders will be issued to the H1 Bidders for deposit of 100 % Sale Value. Non deposit of the sale value within the stipulated period will lead to cancellation of the Acceptance Order and forfeiture of EMD.
- VII. The Bidders are required to quote in Indian Rupees/Quintal for each item on offer.
- VIII. The incremental Price tick size shall be Rs.1.00/Quintal.

- IX. The incremental tick size for the quantity will be 10 Quintal.
- X. The highest valid bid(s), as available in bid sheet, shall be the H-1 bidder(s) after decision by JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT for the e-Auction. JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT has sole discretion of declaring the H-1 bidder(s) as winner(s) or rejecting the H-1 bid(s). Declaration of H1 price/rate will be done Warehouse/Location wise.
- XI. During price discovery session, a bidder may modify his bid only upwards to an incremental value more than the existing highest bid.
- XII. No cancellation of Bids shall be allowed during an auction session.
- XIII. BEAM shall submit bid history through email to mpmfpit@gmail.com either on the same or on the next working day of the bidding date.
- XIV. The final results of the e-Auction are binding on all bidders and any requests for cancellation of Bids received after the conclusion of an auction session and confirmation will not be considered. In any such case of non-compliance, Bidders will be blacklisted and debarred from participation in further tenders/e-Auction of any commodity floated by JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT.
- XV. Any bid placed using the bidder's username and the password shall be deemed to be an unconditional binding on the bidder who has registered with BEAM's portal and have their username and password, inter-alia, for the purpose of the e-Auction and the bidder shall be solely and fully responsible for all the activities that through such username and password. The user is therefore advised to check the username and the password before the e-Auction and is advised not to reveal it to anyone else so as to prevent misuse of the same.
- XVI. The bidders participating in the auction process should participate diligently and submit bids in a fair manner. The bidders should not conduct any act or submit bids which are detrimental to the bidding process and likely to cause disruption or disturb the market equilibrium. In case of any act or omission on the part of any bidders, including participation and entering bids in the bidding process, is likely to cause disruption, effect market equilibrium or result in malpractice or manipulation of the bidding process, JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT may at its sole and absolute discretion, in the best interest of the entire bidding process and other participants at large, with or without giving notice to any such bidder and/or without assigning any reasons whatsoever, may debar/disqualify any bidder or restrict participation of such bidder in the bidding process. The decision of JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT in this regard shall be final and binding on all the bidders. Such non-serious bidders may further be debarred or blocked from participating in future bidding process.
- XVII. JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT reserves the right to accept or reject any or all bids including the highest bid wholly or partially or counter the bid(s) including right to increase or decrease the quantity without assigning any reasons thereof and the bidder shall not raise any dispute.

10. INTERNET CONNECTIVITY

JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT and BEAM shall not be responsible for any failure of power, Network Server, Bandwidth problems, Hosting Server, Internet Connectivity, ISP or otherwise or the slowness to access Portals. In case the scheduled e-auctions are not completed/concluded as intended on account of any reasons whatsoever including any technical reasons, the e-auctions will be rescheduled as per JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT discretion.

11. TRANSACTION CHARGES

BEAM will levy transaction charges from the successful bidders. BSE E-Agricultural Markets Ltd shall charge transaction charge of 0.4% + (applicable GST extra) of the contract value from the Buyer, which the Buyer shall have to pay directly to BSE e-Agricultural Markets Ltd at the time of depositing 10% EMD with BEAM. The transaction charges of only successfully bidders will be deducted after the approval from JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT. No charges to be collected from JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT for the said auction process. 12. PAYMENT AND LIFTING OF THE STOCK

If Buyer fails to deposit the full Sale Value amount within the stipulated time period of 7 Bank working days, the EMD of 10% will be forfeited & Acceptance Order will stand cancelled.
- II. The successful bidder will get 20 days Free Lifting Period from the date of sale confirmation order.
- III. Sale Value as stipulated in the Acceptance Order has to be deposited in favor of JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT through RTGS/NEFT/Online Mode. JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT bank account details -Bank' Name **ICICI Balaghat, 185705500282 IFSC – ICIC0001857**
- IV. Delivery of the stocks would be made in presence of JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT representative within the working hours on 100 percent weightment basis at weighbridges/weighing scale.
- V. Since sale is on ex-warehouse and “**As is Where is**” basis, all expenses such as labor charges, loading charges, weightment charges, container etc. will be borne by the buyer.
- VI. No complaint of any nature regarding quality, weight, etc. would be entertained after sale confirmation/delivery since the sale is on “as is where is” basis. Parties desirous of inspecting the stocks may do so before participation in tender/ e-Auction.
- VII. 5% GST, 1% ABS, Mandi Tax, 2.5% income tax and all other levies/tax as applicable would be extra.
- VIII. JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT shall issue the Tax Invoice at the time of lifting of goods.
- IX. If the available quantity of the Mahua Flower stock is less than the bid quantity, then allocation to the buyer will be done as per the available quantity.

- X. In case, where delivery falls short of the quantity paid for, on account of less stock available with JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT, the costs to that extent will be refunded to buyers by JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT without interest.

13. ISSUANCE OF SALE ORDER

JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT will issue Sale Order in favor of the successful buyer only on receipt of 100% payment of value of sale transaction inclusive of all taxes, charges etc. Payment has to be done in JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT bank account from successful bidder. JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT will not be responsible for delay on part of bank/bank server etc.

Buyers Non-Performance: Following cases will be treated as buyer non-performance

In case Buyer has paid the full amount within 7 Bank working days but fails to lift the material within maximum of TWENTY (20) DAYS from date of sale confirmation, buyer's EMD amount will be forfeited by BEAM & transferred to JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT after deduction of BEAM Transaction charges along with applicable GST and fresh e-Auction will be conducted.

14. LIQUIDATING DAMAGES

- I. In case buyer fails to comply with the payment and delivery condition as stipulated in the contract, the EMD Value received by the JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT will be forfeited without notice.
- II. The payment received by BEAM against such auction will be transferred to JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT.

15. FORCE MAJEURE

- I. Force Majeure means any event or combination of events or circumstances beyond the control of the parties hereto which cannot
 - a) by the exercise of reasonable diligence, or
 - b) despite the adoption of reasonable precaution and/ or alternative measures, be prevented, or caused to be prevented, and which adversely affects the abilities of the parties to perform obligations under this Agreement, which shall include but not be limited to:
 - (i) Acts of God i.e., fire, drought, flood, earthquake, epidemics, natural disasters.
 - (ii) Explosions or accidents, air crashes and shipwrecks, act of terrorism.
 - (iii) Strikes or lock outs, industrial dispute.
 - (iv) War and hostilities of war, riots, bandh, act of terrorism or civil commotion.
 - (v) The promulgation of or amendment in any law, rule or regulation or the issue of any injunction, court order or direction from any Governmental Authority that prevents or restricts a party from complying with any or all the terms and conditions as agreed in this Agreement.
 - (vi) Any event or circumstances analogous to the foregoing.
- II. It is agreed between the parties that the performance of obligations under this contract is subject to

Force Majeure condition which shall mean any event or combination of events or circumstances beyond the control of the parties hereto.

- III. Neither party will be liable for performance delays or for nonperformance due to causes beyond its reasonable control, except for payment obligations.
- IV. During the continuance of the Force Majeure, JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT reserves the right to alter or vary the terms and conditions of this e-Auction or if the circumstances so warrant, the JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT may also suspend the deal for such period as is considered expedient, Buyers agree and consent that they shall have no right to raise any claim, compensation of any nature whatsoever for or with regard to such suspension.
- V. The Buyer agrees and understand that if the Force Majeure condition continues for a long period, then the JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT in its own judgment and discretion may terminate this deal and, in such case, Buyers agree that they shall have no right or claim of any nature whatsoever and JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT shall be released and discharged of all its obligations and liabilities under this Agreement.

16. APPLICABLE LAW JURISDICTION AND DISPUTE RESOLUTION

- I. The contract / Tender document shall be constituted and the legal relation between the parties hereto shall be determined and governed according to the laws of Republic of India and only courts at Bhopal shall have the jurisdiction in all matters arising out of/ touching and/or concerning this agreement and parties to this agreement agree to irrevocably submit to the exclusive jurisdiction of those courts for purposes of any such proceeding. The aforementioned exclusive and irrevocable jurisdictions of aforesaid courts are irrespective of place of occurrence of any cause of action pertaining to any dispute between the parties.
- II. In case of any dispute arises between the parties, the same shall be resolved mutually by the parties and in case if any further dispute subside then the same shall be referred to the Manager, JILA LAGHU VANOPAJ UNION, NORTH BALAGHAT whose decision will be treated as final and binding on both the parties.
- III. The provision of Arbitration and Conciliation Act 1996 will not be applicable to the subject matter of this e-Auction.
